PLEASE READ CAREFULLY BEFORE BIDDING ON AUCTION

REGISTRATION:

To obtain a bidders card we require FICA documents together with R 5 000.00 deposit payable by **EFT only**.
No cash/card payments.

Kindly note the FICA documents required:

Private Individuals

- ID as well as driver's license
- Proof of residence (Utility bill not older than 3 months)

Company/Dealers

- ID's of all members
- Proof of residence of members (Utility bill not older than 3 months)
- Proof of address of business (Utility bill not older than 3 months)
- Company registration documents
- Resolution from company authorising representative to bid
- Tax certificate

PAYMENT:

R 5 000.00 registration fee payable on registration by means of **EFT only**.

A storage fee of R 250.00 per lot will be charged on vehicles not collected by 16h00 the Friday after the auction.

- Finance must be arranged prior to auction. Clients must provide a bank release note within 48 hours from conclusion of the sale
